

A BETTER PET LLC BOARDING AGREEMENT

Description:

Your dog will be living in a home, not a kennel. Your dog will be under the supervision of experienced Positive Reinforcement Dog Trainers. Your dog's days will include feeding(s) as directed, potty breaks and playtime in a fenced in backyard as well as full integration into an active household with other well trained and socialized resident dogs. No doubt your dog will get some positive indoor interactions as well.

Boarding differs greatly from Board & Train services with respect to intensity, individualized attention and training focus on owner and/or trainer identified problem areas. These include basic manners (the six things all dogs should know), socializing well with people and other animals, dealing gracefully with distractions, learning clear boundaries, improving leash manners and increasing self control. For well behaved dogs who do not require a lot of individualized attention, boarding is a good option but it is NOT a training program. We reserve the right to refuse service for boarding based on the needs of the dog being boarded.

RATES PER DOG

Half Day (up to 6 hours) • \$30 — useful for young not yet house trained pups, anticipated delays, etc.

Day Rate (up to 12 hours) • \$45 — useful for special events, home repair, unexpected day trip, etc.

Overnight Rate (up to 24 hours) • \$60 — useful for away trips, vacations, celebrations, etc.

Note: You provide food, equipment, treats and chewies. (bully sticks available for purchase if desired)

OPTIONS/EXTRAS:

Pick up Service/Delivery Fees

Varies based on mileage from Board & Train residence starting at \$15 each way.

Bath (shampoo & conditioner): \$15 (under 20 lbs) \$30 (20-40 lbs); \$35 (over 40 lbs.)

Terms:

50% deposit required upon delivery/pick up of dog; balance due in full upon return of dog. Or pay in full upon drop off. NO EXCEPTIONS. We take cash, check (payable to A Better Pet LLC) or you can pay through paypal.com to rachel@abetterpet.com.

NO Drop offs before 8 am / NO pick ups after 8 pm **unless agreed upon in advance.**
